confirms the right to use the waters of ROUGH AND READY CREEK, a tributary of WEST FORK ILLINOIS RIVER, for IRRIGATION OF 6.2 ACRES AND STOCK.

This right was confirmed by decree of the Circuit Court of the State of Oregon for JOSEPHINE COUNTY. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 13, at Page 70. The date of priority is SEPTEMBER 15, 1899.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed ONE CUBIC FOOT PER SECOND FOR EACH 50 ACRES OF LAND IRRIGATED DURING THE IRRIGATION SEASON FROM APRIL 1 TO NOVEMBER 1 OF EACH YEAR.

The point of diversion is located as follows:

WING & FARREN DITCH - NE 1/4 SW 1/4, SECTION 14, TOWNSHIP 40 SOUTH, RANGE 9 WEST, W.M.

A description of the place of use to which this right is appurtenant is as follows:

NE 1/4 SE 1/4	1.9 ACRES (BROWN - TAX LOT 1002)
NE 1/4 SE 1/4	2.3 ACRES (BUCK - TAX LOT 1000)
SE 1/4 SE 1/4	2.0 ACRES (EMONDS - TAX LOT 1001)
SECTION 12	
TOWNSHIP 40 SOUTH, RANGE 9 WEST, W.M.	

The diversion works shall include an in-line flow meter, a weir, or other suitable device for measuring the water to which the water user is entitled.


The type and plans of the measuring device be approved by the Watermaster before the beginning of construction work and the weir or measuring device be installed under the general supervision of the Watermaster.

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered FEBRUARY 17, 1987, and together with Certificate 55919, supersedes Certificate 40974, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
