## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

CITY OF STANFIELD P.O. BOX 368 STANFIELD, OREGON 97875

confirms the right to use the waters of UMATILLA RIVER, a tributary of COLUMBIA RIVER, for MUNICIPAL AND DOMESTIC SUPPLY FOR THE CITY OF STANFIELD.

This right was confirmed by decree of the Circuit Court of the State of Oregon for UMATILLA COUNTY. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 3, at Page 127. The date of priority is SEPTEMBER 11, 1894.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 11.5 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

Dillon Ditch - SE 1/4 NW 1/4, Section 8, Township 3 North, Range 29 East, W.M.; and

Well - NW 1/4 SE 1/4, Section 31, Township 4 North, Range 29 East, W.M.; 500 Feet South and 150 Feet East from the Center 1/4 Corner of Section 31.

A description of the place of use to which this right is appurtenant is as follows:

## MUNICIPAL AND DOMESTIC SUPPLY FOR THE CITY OF STANFIELD

THE PLACE OF USE OF WATER DESCRIBED HEREIN DOES NOT AUTHORIZE NOR CHANGE THE PLACE OF USE ALLOWED BY THE RIGHT EVIDENCED BY DECREE OF THE CIRCUIT COURT OF UMATILLA COUNTY WHICH DOES NOT SPECIFICALLY DESCRIBE THE PLACE OF USE OF THE RIGHT.

The quantity of water diverted at the well, together with that diverted at Dillon Ditch, shall not exceed the quantity of water lawfully available at the Dillon Ditch Diversion.

The water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered JUNE 30, 1999, and together with Certificate 75454, supersedes Certificate 55602, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
