CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ELKHORN VALLEY GOLF COURSE 32295 NORTH FORK ROAD LYONS, OREGON 97358

confirms the right to use the waters of UNNAMED STREAMS AND RESERVOIR A CONSTRUCTED UNDER PERMIT R-6116, tributaries of LITTLE NORTH FORK SANTIAM RIVER, for SUPPLEMENTAL IRRIGATION OF 52.5 ACRES FROM RESERVOIR A AND AESTHETIC PURPOSES FROM UNNAMED STREAMS.

This right was perfected under Permit 37778. The date of priority is FEBRUARY 26, 1975. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1.65 CUBIC FEET PER SECOND(CFS); BEING 0.65 CFS FROM RESERVOIR A ENLARGEMENT FOR SUPPLEMENTAL IRRIGATION AND 0.5 CFS FROM WESTERLY STREAMS AND 0.5 CFS FROM EAST STREAM FOR AESTHETICS, or its equivalent in case of rotation, measured at the point of diversion from the sources.

The points of diversion are located as follows:

WESTERLY STREAMS - SE 1/4, SECTION 10, TOWNSHIP 9 SOUTH, RANGE 3 EAST, W.M.;

RESERVOIR A - NW 1/4 SW 1/4, SECTION 11, TOWNSHIP 9 SOUTH, RANGE 3 EAST, W.M.:

EASTERLY STREAM - SE 1/4 NE 1/4, SECTION 10, SW 1/4 NW 1/4 AND NW 1/4 SW 1/4, SECTION 11, TOWNSHIP 9 SOUTH, RANGE 3 EAST, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of not to exceed 2 ½ acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage. This right is limited to any deficiency in the available supply of any prior right existing for the same land.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
