CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ELKHORN VALLEY GOLF COURSE 32295 NORTH FORK ROAD LYONS, OREGON 97358

confirms the right to use the waters of AN UNNAMED STREAM AND RESERVOIR CONSTRUCTED UNDER PERMIT R-1393, a tributaries of LITTLE NORTH FORK SANTIAM RIVER, for IRRIGATION OF 52.5 ACRES.

This right was perfected under Permit 21578. The date of priority is OCTOBER 9, 1951. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.65 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NW 1/4 SW 1/4, SECTION 11, TOWNSHIP 9 SOUTH, RANGE 3 EAST, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 ½ acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit R-1393.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered MARCH 3, 1975, and supersedes Certificate 22818, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
