CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of the SOUTH FORK YAMHILL RIVER, a tributary of the YAMHILL RIVER, for IRRIGATION OF 16.3 ACRES.

This right was perfected under Permit 18197. The date of priority is FEBRUARY 6, 1948 FOR 0.01 CUBIC FOOT PER SECOND (CFS) AND APRIL 22, 1948 FOR 0.20 CFS. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.21 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

NW% NW%, AS PROJECTED WITHIN A. MILLER DLC 64, SE% NW%, AS PROJECTED WITHIN J. MONROE DLC 74, SECTION 12, T 5 S, R 5 W, W.M..

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
