CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ELTON V. JACKSON P.O. BOX 36 WINCHESTER, OREGON 97467

confirms the right to use the waters of the NORTH UMPQUA RIVER, a tributary of the UMPQUA RIVER, for IRRIGATION OF 240.7 ACRES.

This right was perfected under Permit 19661. The date of priority is MAY 10, 1950. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 2.978 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

SE% SE%, AS PROJECTED WITHIN SMITH DLC 44, SECTION 24, T 26 S, R 6 W, W.M.

NW% NE%, AS PROJECTED WITHIN REED DLC 47, SECTION 30, T 26 S, R 5 W, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre-feet for each acre irrigated during the irrigation season of each year, subject to the terms and conditions of that agreement between Elton V. Jackson and the California Oregon Power Company dates September 1, 1950.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
