CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of the UMATILLA RIVER, a tributary of the COLUMBIA RIVER, for IRRIGATION, AND STOCK WATER OF 117.0 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for UMATILLA COUNTY. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 3, at Page 229, under the name of Will Moore, as modified by an Order of the Water Resources Director entered September 10, 1987, approving Transfer 5763; and the decree recorded at Volume 15, Page 429, under the name of J. F. Murray, as modified by an Order of the Water Resources Director entered September 12, 1984, approving Transfer 5494. The date of priority is JANUARY 9, 1900, for 105 acres, and 1900 for 12 acres.

The use is limited to 1.46 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the Umatilla River.

The point of diversion is located as follows:  
NORTH 76 DEGREES 45 MINUTES 56 SECONDS EAST 2913.19 FEET FROM THE WEST 1/4 CORNER OF SECTION 21, BEING WITHIN SW 1/4 NE 1/4 OF SECTION 21, TOWNSHIP 3 NORTH, RANGE 29 EAST, W.M. UMATILLA COUNTY.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) from MARCH 1 to NOVEMBER 1 and subject to the limitations of paragraph 32 of the Umatilla River Decree for each acre irrigated during the irrigation season of each year.



Murray. This certificate supersedes Certificate number 76719 in State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said permit.
