CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

STATE OF OREGON WATER RESOURCES DEPARTMENT SALEM, OREGON 97310

confirms the right to use the waters of SQUAW CREEK, a tributary of the DESCHUTES RIVER, to maintain instream flow for FISHERIES ENHANCEMENT.

These rights were confirmed by decree of the Circuit Court of the State of Oregon for CROOK County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 1, at Pages 120, 433, and 471. The date of priority is 1885.

The amount of water to which these rights is entitled is limited to an amount actually beneficially used and shall not exceed 1.61 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the original point of diversion from the source, during the period from MARCH 1 to OCTOBER 31, of each year.

The original point of diversion is located as follows:

SMITH DITCH, NW1/4 SW1/4, SECTION 9, T 15 S, R 10 E, WM.

A description of the stream reaches to which this right is appurtenant is as follows:

From the authorized point of diversion, Smith Ditch, in the NW1/4 SW1/4, SECTION 9, T 15 S, R 10 E, WM, to the confluence with Indian Ford Creek in the SE1/4 SW1/4, SECTION 3, T 13 S, R 12 E, WM; and, from the confluence of Indian Ford Creek to the mouth in the SE¼ NE¼, SECTION 7, T 13 S, R 12 E, WM.

This instream right shall replace a portion of the existing instream water rights for Squaw Creek, evidenced by Certificates 73223 and 73224, during the period from March 1 to October 31, of each year.

This certificate corrects a scrivener's error contained in the certificate recorded at page 75839, State Record of Water Right Certificates. Certificate 75839 misidentified the remaining right certificates resulting from Transfer Application 7958 and which supersede Certificates 448 and 12307. This certificate supersedes Certificate 75839.

This Certificate confirms changes in use and places of use approved by orders of the Water Resources Director approving Transfers 7839 and 7958, and together with Certificates 75840 and 75841, supersedes Certificates 448 and 12307, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
