CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

BEN AND HAZEL O. ELLIS ROUTE 1, BOX 415A CORVALLIS, OREGON

confirms the right to use the waters of TWO WELLS in the WILLAMETTE RIVER BASIN for IRRIGATION OF 93.6 ACRES.

This right was perfected under Permit G-3341. The date of priority is JUNE 28, 1966. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1.17 CUBIC FEET PER SECOND (CFS), BEING 0.79 CFS FROM EAST WELL AND 0.38 CFS FROM WEST WELL, or its equivalent in case of rotation, measured at the well.

The wells are located as follows:

EAST WELL - SW¼ NE¼, AS PROJECTED WITHIN COOK DLC 86, SECTION 17, T 11 S, R 4 W, W.M.; 1070 FEET SOUTH AND 560 FEET WEST FROM THE SE CORNER OF TAYLOR DLC 46, SECTION 17, T 11 S, R 4 W, W.M.

WEST WELL - SW¼ NW¼, AS PROJECTED WITHIN SYLVESTER DLC 47, SECTION 17, T 11 S, R 4 W, W.M.; 1170 FEET SOUTH AND 2520 FEET WEST FROM THE SE CORNER OF TAYLOR DLC 46, SECTION 17, T 11 S, R 4 W, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
