CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

FARRELL LARSON LARSON SKYLINE FARMS 4395 HEINZE BLVD ONTARIO, OR 97914

confirms the right to use the waters of the SNAKE RIVER, a tributary of COLUMBIA RIVER, for IRRIGATION OF 623.7 ACRES.

This right was perfected under Permit 31231. The date of priority is JUNE 27, 1966. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 12.77 CUBIC FEET PER SECOND AND A VOLUME OF 2494.8 ACRE-FEET EACH YEAR or its equivalent in case of rotation, measured at the point of diversion from the source, provided further the total quantity of water allowed herein, along with the amount perfected under permits 30621, 31231, 33944, 33945 and 33946 shall not exceed the capacity of the diversion systems at the time of perfection of the rights.

The point of diversion is located as follows:

LOT 1 (NE¼ NW¼), SECTION 21, T 17 S, R 47 E, W.M.; 350 FEET SOUTH AND 1980 FEET EAST FROM THE NW CORNER, SECTION 21.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.0 acre-feet for each acre irrigated during the irrigation season of each year. The irrigation season under this right is limited to March 1 to October 31 of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
