 CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of the SNAKE RIVER, a tributary of COLUMBIA RIVER, for IRRIGATION OF 632.7 ACRES.

This right was perfected under Permit 33944. The date of priority is OCTOBER 25, 1968. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 15.82 CUBIC FEET PER SECOND AND A VOLUME OF 2531.6 ACRE-FEET EACH YEAR or its equivalent in case of rotation, measured at the point of diversion from the source, provided further the total quantity of water allowed herein, along with the amount perfected under permits 30621, 31231, 33944, 33945 and 33946 shall not exceed the capacity of the diversion systems at the time of perfection of the rights.

The point of diversion is located as follows:

LOT 1 (NE 1/4 NW 1/4), SECTION 21, T 17 S, R 47 E, W.M.; 350 FEET SOUTH AND 1980 FEET EAST FROM THE NW CORNER, SECTION 21.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.0 acre-feet for each acre irrigated during the irrigation season of each year. The irrigation season under this right is limited to March 1 to October 31 of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.


TOWNSHIP 17 SOUTH, RANGE 46 EAST, W.M.

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered FEBRUARY 25, 1997, together with Certificate 74023 AND 76949, supersedes Certificate 40572, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
