## CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of MALHEUR RIVER, a tributary of SNAKE RIVER, for FLOW AUGMENTATION FISH ENHANCEMENT.

This right was perfected under Permit 30621. The date of priority is OCTOBER 8, 1965. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 37.88 CUBIC FEET PER SECOND AND A VOLUME OF 9423.3 ACRE-FEET EACH YEAR, or its equivalent in case of rotation, measured at the point of diversion from the source, provided further the total quantity of water allowed herein, along with the amount perfected under permits 30621, 31231, 33944, 33945 and 33946 shall not exceed the capacity of the diversion systems at the time of perfection of the rights.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the river reach to which this right is appurtenant is as follows:

MALHEUR RIVER - NE 1/4 NE 1/4, SECTION 10, TOWNSHIP 18 SOUTH, RANGE 46 EAST, W.M.; 510 FEET SOUTH AND 600 FEET WEST FROM THE NE CORNER OF SECTION 10 DOWNSTREAM TO THE CONFLUENCE OF THE SNAKE RIVER AND OREGON-WASHINGTON STATE BORDER IN LOT 1 (SE 1/4 SE 1/4), SECTION 15, TOWNSHIP 6 NORTH, RANGE 46 EAST, W.M.

The water user shall work with the Department to develop and implement a strategy for monitoring the flows under this right.

This certificate is issued to confirm a change in use of water approved by an order of the Water Resources Director entered February 25, 1997, and together with Certificate 74024, supersedes Certificate 40570, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
