CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

RONALD F. AND ANNIE I. MEINTS
5615 INVERNESS AVE
SANTA ROSA, CA 95404

confirms the right to use the waters of UMPQUA RIVER, a tributary of PACIFIC OCEAN, for IRRIGATION OF 161.1 ACRES.

This right was perfected under Permit 42481. The date of priority is OCTOBER 3, 1977. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 2.01 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

NE 1/4 SW 1/4, AS PROJECTED WITHIN DLC 45, SECTION 16, TOWNSHIP 22 SOUTH, RANGE 8 WEST, W.M.; 3890 FEET SOUTH AND 1200 FEET EAST FROM THE NW CORNER OF SECTION 16;

SE 1/4 NW 1/4, AS PROJECTED WITHIN DLC 47, SECTION 16, TOWNSHIP 22 SOUTH, RANGE 8 WEST, W.M.; 1600 FEET SOUTH AND 2480 FEET EAST FROM THE NW CORNER OF SECTION 16; AND

NW 1/4 SE 1/4, AS PROJECTED WITHIN DLC 57, SECTION 9, TOWNSHIP 22 SOUTH, RANGE 8 WEST, W.M.; 2230 FEET NORTH AND 3100 FEET EAST FROM THE NW CORNER OF SECTION 16.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:


