CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

MORROW BROTHERS 1204 CHESTNUT AVENUE MADRAS, OREGON 97741

confirms the right to use the waters of WILLOW CREEK, a tributary of DESCHUTES RIVER, for IRRIGATING 230.52 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for DESCHUTES County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 9, at Page 362. The date of priority is 1886.

The use is limited to 3.84 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

SE 1/4 SE 1/4 SECTION 19, NE 1/4 SE 1/4 SECTION 20, NW 1/4 SW 1/4, SW 1/4 SE 1/4 SECTION 21, TOWNSHIP 12 SOUTH, RANGE 15 EAST, W.M.; DIVERSION 2A- 1580 FEET NORTH AND 5220 FEET EAST, DIVERSION 3 (DAM)- 380 FEET NORTH AND 80 FEET WEST, BOTH FROM THE SOUTHWEST CORNER OF SECTION 20; DIVERSION 2 - 1400 FEET NORTH AND 1000 FEET EAST, DIVERSION 1 - 350 FEET NORTH AND 2650 FEET EAST, BOTH FROM THE SOUTHWEST CORNER OF SECTION 21, TOWNSHIP 12 SOUTH, RANGE 15 EAST, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-SIXTIETH of one cubic foot per second (or its equivalent) and 2.0 acre-feet for each acre irrigated during the irrigation season **from April 1 to November 1 of each year.**
