## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JIM NARTZ P.O. BOX 25 ASHWOOD, OREGON 97711

confirms the right to use the waters of TROUT CREEK, a tributary of DESCHUTES RIVER, for IRRIGATION OF 23.0 ACRES, DOMESTIC AND STOCK USE.

This right was confirmed by decree of the Circuit Court of the State of Oregon for JEFFERSON COUNTY. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 5, at Page 57. The date of priority is 1891.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1.5 ACRE FEET PER ACRE DURING ANY PERIOD OF 30 DAYS OR 6.0 ACRE FEET PER ACRE DURING ANY IRRIGATION SEASON. THE QUANTITY OF WATER DIVERTED AT THE NEW POINT OF DIVERSION, SHALL NOT EXCEED THE QUANTITY OF WATER AVAILABLE AT THE ORIGINAL POINT OF DIVERSION DESCRIBED AS FRIEND DITCH 4 (NW 1/4 NE 1/4, SECTION 36, TOWNSHIP 9 SOUTH, RANGE 16 EAST, W.M.).

The point of diversion is located as follows:

NW 1/4 SE 1/4, SECTION 25, TOWNSHIP 9 SOUTH, RANGE 16 EAST, W.M.; 220 FEET NORTH AND 230 FEET EAST FROM THE SW CORNER, NW 1/4 SE 1/4, SECTION 25.

A description of the place of use to which this right is appurtenant is as follows:

SW 1/4 NE 1/4 4.4 ACRES
SE 1/4 NW 1/4 3.6 ACRES
NE 1/4 SW 1/4 8.8 ACRES
SE 1/4 SW 1/4 1.1 ACRES
NW 1/4 SE 1/4 5.0 ACRES
SW 1/4 SE 1/4 0.1 ACRE
SECTION 25

TOWNSHIP 9 SOUTH, RANGE 16 EAST, W.M.

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered JANUARY 27, 1978, and together with Certificate 72481, supersedes Certificate 2234, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
