## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

OREGON STATE BOARD OF CONTROL -DAMMASCH STATE HOSPITAL P.O. BOX 38 WILSONVILLE, OR 97070

confirms the right to use the water of F. H. DAMMASCH WELL #2, a tributary of the CORRAL CREEK, a tributary of the WILLAMETTE RIVER, for IRRIGATION of 16.50 ACRES and SUPPLEMENTAL IRRIGATION of 7.40 ACRES.

The right was perfected under PERMIT G-1837. The date of priority is APRIL 27, 1961. The amount of water to which such right is entitled for the purposes aforesaid is limited to an amount actually beneficially used for said purposes and shall not exceed 0.28 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

F. H. DAMMASCH WELL #2 -- SE¼ SE¼, Section 16, T 3 S, R 1 W, W. M.; 160 feet North and 280 feet West from the SE Corner, Section 16.

The amount of water used for irrigation with the amount secured under any other right existing for the same lands shall be limited to ONE-EIGHTIETH of one cubic foor per second per acre, or its equivalent for each acre irrigated and shall further be limited to a diversion not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year.

The use of water under this right for irrigation shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
