CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

OREGON STATE BOARD OF CONTROL -DAMMASCH STATE HOSPITAL P.O. BOX 38 WILSONVILLE, OR 97070

confirms the right to use the water of a WELL, a tributary of the CORRAL CREEK, for SUPPLEMENTAL IRRIGATION of 9.10 ACRES.

The right was perfected under PERMIT G-7666. The date of priority is JULY 28, 1977. The amount of water to which such right is entitled for the purposes aforesaid is limited to an amount actually beneficially used for said purposes and shall not exceed 0.11 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

F. H. DAMMASCH WELL #2 -- SE¼ SE¼, Section 16, T 3 S, R 1 W, W. M.; 160 feet North and 280 feet West from the SE Corner, Section 16.

The amount of water used for irrigation with the amount secured under any other right existing for the same lands shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall further be limited to a diversion not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year.

The use of water under this right for irrigation shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

portion of said water right.	

The issuance of this superseding certificate does not confirm the status of the water right in regards to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
