CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

DORCAS AND MARSHALL MCELHERAN
56626 JUNIPER FLAT ROAD
MAUPIN, OR 97037

confirms the right to use the waters of A WELL, a tributary of WHITE RIVER, for IRRIGATION OF 14.0 ACRES AND SUPPLEMENTAL IRRIGATION OF 123.5 ACRES.

This right was perfected under Permit G-7958. The date of priority is FEBRUARY 14, 1978. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.89 CUBIC FOOT PER SECOND or its equivalent in case of rotation measured at the point of diversion from the source.

The point of diversion is located as follows:

NE¼ NE¼, SECTION 23, T. 4 S., R. 13 E., W.M.; 1360 FEET NORTH AND 80 FEET WEST FROM E¼ CORNER SECTION 23.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:


The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said permit.
