CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

HENRY J. YAGER AND JACOB C. YAGER
BOYD, OREGON 97021

confirms the right to use the waters of EIGHT MILE CREEK, a tributary of FIFTEEN MILE CREEK, for IRRIGATION OF 14.2 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for WASCO County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 7, at Page 406. The date of priority is 1892 FOR TRACT #1; 1895 FOR TRACT #2; AND 1901 FOR TRACT #3.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.18 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SW $\frac{1}{4}$ SE $\frac{1}{4}$, SECTION 19, T 1 S, R 13 E, W.M.; 290 FEET NORTH AND 2200 FEET WEST FROM THE SE CORNER, SECTION 19.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of not to exceed 3 acre-feet for each acre irrigated during the irrigation season of each year.

A description of the place of use to which this right is appurtenant is as follows:

SW $\frac{1}{4}$ SE $\frac{1}{4}$ 0.5 ACRE
SE $\frac{1}{4}$ SE $\frac{1}{4}$ 3.2 ACRES
SECTION 19


TOWNSHIP 1 SOUTH, RANGE 13 EAST, W.M.

This certificate describes that portion of the water right confirmed by Certificate 5682, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered JUN 20 2001, approving Transfer Application 8595.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
