CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ROWENA M. BOSTWICK

PENDLETON, OREGON 97801

confirms the right to use the waters of WELLS NO. 1 AND 2 in the WALLA WALLA RIVER BASIN for IRRIGATION OF 7.5 ACRES AND SUPPLEMENTAL IRRIGATION OF 37.7 ACRES.

This right was perfected under Permit G-5880. The date of priority is JULY 18, 1973. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.57 CUBIC FOOT PER SECOND (IF AVAILABLE AT WELL NO. 1), or its equivalent in case of rotation, measured at the wells.

The wells are located as follows:

WELL NO. 1 - LOT 2 (SW 1/4 NE 1/4), SECTION 13, TOWNSHIP 6 NORTH, RANGE 34 EAST, W.M.; 270 FEET SOUTH AND 1420 FEET WEST FROM THE NE CORNER, LOT 1 (SE 1/4 NE 1/4), SECTION 13; AND

WELL NO. 2 - LOT 3 (SE 1/4 NW 1/4), SECTION 13, TOWNSHIP 6 NORTH, RANGE 34 EAST, W.M.; 395 FEET SOUTH AND 3670 FEET WEST FROM THE NE CORNER, LOT 1 (SE 1/4 NE 1/4), SECTION 13.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. This right is limited to any deficiency in the available supply of any prior right existing for the same land.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.


When required by the Department the water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate is issued to confirm a change in POINT OF APPROPRIATION approved by an order of the Water Resources Director entered MARCH 31, 1997, and supersedes Certificate 47959, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
