## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

VERN AND PENNY RODIGHIERO PO BOX 226 MILTON-FREEWATER, OREGON 97862

confirms the right to use the waters of the WALLA WALLA RIVER, a tributary of the COLUMBIA RIVER, routed into the LITTLE WALLA RIVER at the control structure located 7,091 feet south and 3,450 feet east of the northwest corner of Section 1, T 5 N, R 35 E, WM., for IRRIGATION of 7.66 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for UMATILLA County. The decree is of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 12, at Page 9. The dates of priority are 1896 for 2.00 acres, 1898 for 2.00 acres, and 1903 for 3.66 acres. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.176 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source, being 0.046 CUBIC FEET PER SECOND with a priority of 1896, 0.046 CUBIC FEET PER SECOND with a priority of 1898, and 0.084 CUBIC FEET PER SECOND with a priority of 1903.

The point of diversion is located as follows:

NO °07' W, 612 FEET FROM THE SOUTHWEST CORNER OF SECTION 36, T 6 N, R 35 E, WM. ON THE EAST CROCKET BRANCH OF THE LITTLE WALLA RIVER.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

SW<sup>1</sup>/<sub>4</sub> SW<sup>1</sup>/<sub>4</sub> 7.66 ACRES SECTION 36 TOWNSHIP 6 NORTH, RANGE 35 EAST, W.M.

This certificate is issued to confirm the reduction in the rate of diversion and transfer of lands approved by an order of the Water Resources Director entered June 27, 2001, in Volume 55, Page 705, Special Order Records of the Water Resources Department, approving Allocation of Conserved Water Application 11 and supersedes Certificate 12867, State Record of Water Right Certificates.

The issuance of this certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows and is subject to all other terms and conditions of the original certificate, including those of the decree.
