CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

REDLANDS DITCH AND IRRIGATION COMPANY KERBY, OREGON 97531

confirms the right to use the waters of SUCKER CREEK, a tributary of the ILLINOIS RIVER, for IRRIGATION OF 93.2 ACRES AND DOMESTIC FOR TRACT 1; IRRIGATION OF 14.3 ACRES FOR TRACT 2.

This right was confirmed by decree of the Circuit Court of the State of Oregon for JOSEPHINE County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volumes 1 AND 5, at Pages 253 AND 398. The date of priority is 1893 FOR TRACT 1 AND 1908 FOR TRACT 2.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1.864 cubic foot per second for TRACT 1, 0.182 cubic foot per second for TRACT 2, or its equivalent in case of rotation measured at the point of diversion from the source, and that the use of water for irrigation purposes shall be confined to the season APRIL 1 to OCTOBER 31 of each year.
