CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

53333 RESERVATION ROAD
MAUPIN, OR 97037

confirms the right to use the waters of 2 UNNAMED SPRING AND UNNAMED STREAMS FORMED THEREBY, a tributary of CLEAR CREEK, for STOCK.

This right was perfected under Permit 19963. The date of priority is SEPTEMBER 6, 1950 FOR 0.50 CFS AND DECEMBER 2, 1950 FOR 0.50 CFS. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1.0 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:


