CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

GOLDEN RULE FARMS, INC.

confirms the right to use the waters of WELLS 1 AND 2 in the FORT ROCK BASIN for IRRIGATION OF 225.0 ACRES.

This right was perfected under Permit G-9064. The date of priority is JULY 2, 1980. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1.89 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the wells.

The wells are located as follows:

NE $\frac{1}{4}$ NW $\frac{1}{4}$, SE $\frac{1}{4}$ NE $\frac{1}{4}$, SECTION 22, T 26 S, R 18 E, W.M.; WELL 1 - 1320 FEET SOUTH AND 1280 FEET WEST; WELL 2 - 1340 FEET SOUTH AND 1340 FEET EAST; BOTH FROM THE N $\frac{1}{4}$ CORNER, SECTION 22.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:


TOWNSHIP 26 SOUTH, RANGE 18 EAST, W.M.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
