CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

GOLDEN RULE FARMS, INC.

confirms the right to use the waters of ONE WELL in the FORT ROCK BASIN for IRRIGATION OF 258.3 ACRES.

This right was perfected under Permit G-8888. The date of priority is JULY 10, 1980. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 3.23 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

SW $\frac{1}{4}$ SE $\frac{1}{4}$, SECTION 21, T 27 S, R 17 E, W.M.; 80 FEET NORTH AND 40 FEET EAST FROM THE S $\frac{1}{4}$ CORNER, SECTION 21.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.


