## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JULIA RITTER 28100 RITTER ROAD BONANZA, OREGON 97623

confirms the right to use the waters of WELLS  $\sharp 1$  AND  $\sharp 2$ , tributary to WILD HORSE CREEK, for IRRIGATION OF 86.2 ACRES and SUPPLEMENTAL IRRIGATION OF 298.7 ACRES.

This right was perfected under Permit G-3653. The date of priority is JULY 29, 1967. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 4.30 CUBIC FEET PER SECOND (CFS), being 1.08 CFS from Well #1 and 3.22 CFS from Well #2, or the equivalent in case of rotation, measured at the point of diversion from the source.

The wells are located as follows:

WELL #1 - SE4 SW4, SECTION 5, WELL #2 - SW4 NE4, SECTION 8, TOWNSHIP 38 SOUTH, RANGE 11 EAST, W.M.; WELL #1 - 270 feet North and 2580 feet East, WELL #2 - 2610 feet South and 3000 feet East, both from NW Corner, Section 8.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year; provided further that the right allowed herein shall be limited to any deficiency in available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
