CERTIFICATE OF WATER RIGHT (HB - 2153)

THIS CERTIFICATE ISSUED TO

U.S. BUREAU OF LAND MANAGEMENT

confirms the right to store the waters of UNNAMED INTERMITTENT STREAMS AND SPRINGS, tributaries of COW CREEK, JORDAN CREEK, ANTELOPE RESERVOIR, AND CLOSED BASINS, in EIGHT RESERVOIRS, for LIVESTOCK AND WILDLIFE.

The right to store and use these waters was perfected under Reservoir Application R-74125. The date of priority is JANUARY 1, 1993. The amount of water entitled to be stored and used each year under this right is not more than 9.26 ACRE-FEET (AF), BEING 3.42 AF IN SHEAVILLE PIT RESERVOIR (BLM NO. 48-4744), 0.7 AF IN ROCK CREEK SEEDING PIT #2 RESERVOIR (BLM NO. 68-1906), 0.1 AF IN TWIN SPRING RESERVOIR (BLM NO. 68-5153), 0.59 AF IN NORTH BRICKEY RESERVOIR (BLM NO. 68-5679), 0.02 AF IN GREEN SPRING RESERVOIR (BLM NO. 68-5894), 0.15 AF IN COWGILL WINDMILL PIT RESERVOIR (BLM NO. 68-5735), 3.41 AF IN GRAVEL PIT RESERVOIR (BLM NO. 68-5736), AND 0.87 IN ANGUS PIT RESERVOIR (BLM NO. 68-1686).
