## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

R. DAVID MULKEY PHYLLIS E. MULKEY 501 DELAY DRIVE EUGENE, OREGON 97404

confirms the right to use the waters of ONE WELL in the DESCHUTES BASIN for IRRIGATION OF 158.3 ACRES AND SUPPLEMENTAL IRRIGATION OF 170.7 ACRES.

This right was perfected under Permit G-8341. The date of priority is APRIL 24, 1978. This right is limited to 2.44 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

NE 1/4 SE 1/4, SECTION 30, T 13 S, R 12 E, W.M.; 2760 FEET SOUTH AND 190 FEET WEST FROM THE NORTHEAST CORNER OF SECTION 30.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year. This right is limited to any deficiency in the available supply of any prior right existing for the same land.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

The works shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times.

The water user shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.
