CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

BRUCE H. HULL
ROUTE 2, BOX 60
THE DALLES, OREGON 97058

confirms the right to use the waters of MILL CREEK, a tributary of the COLUMBIA RIVER, for IRRIGATION AND STOCK USE and A SPRING, a tributary of MILL CREEK for DOMESTIC PURPOSES in the SW $\frac{1}{4}$ SE $\frac{1}{4}$.

This right was confirmed by decree of the Circuit Court of the State of Oregon for WASCO County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 8, at Page 119. The date of priority is 1855 FOR TRACT 1 (IRRIGATION AND STOCK); 1882 FOR TRACT 2 (IRRIGATION AND DOMESTIC); AND 1855 FOR DOMESTIC AND [REDACTED]

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed ONE-FORTIETH of one cubic foot per second for each one thousand head of stock, a reasonable amount for domestic purposes, and ONE-SIXTIETH of one cubic foot per second per acre during the irrigation season from APRIL 1 TO OCTOBER 1, if available at the original points of diversion.

The points of diversion are located as follows:

SPRING - SW $\frac{1}{4}$ SE $\frac{1}{4}$, SECTION 14, T 1 N, R 12 E, W.M.;

MILL CREEK DIVERSIONS - SW $\frac{1}{4}$ SE $\frac{1}{4}$, SECTION 14, NE $\frac{1}{4}$ NW $\frac{1}{4}$, SECTION 23, T 1 N, R 12 E, W.M.; TRACT 1 & 2: 110 FEET NORTH AND 1860 FEET WEST FROM THE SE CORNER, SECTION 14; TRACT 1: SANDOZ DITCH - 290 FEET SOUTH AND 2850 FEET WEST; TRACT 2: BRACE DITCH - 880 FEET SOUTH AND 3762 FEET WEST, BOTH FROM THE NE CORNER, SECTION 23.

A description of the place of use to which this right is appurtenant is as follows:

TRACT 1

SW¼ SE¼ 4.5 ACRES (AND STOCK)
SECTION 14
TOWNSHIP 1 NORTH, RANGE 12 EAST, W.M.

TRACT 2


SW¼ SE¼ 3.2 ACRES (AND DOMESTIC)
SECTION 14
TOWNSHIP 1 NORTH, RANGE 12 EAST, WM.

This certificate describes that portion of the water right confirmed by Certificate 50542, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered DEC 17 2001, approving Transfer Application 8638.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
