CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of AN UNNAMED STREAM, a tributary of WEST FORK ILLINOIS RIVER, for DOMESTIC USE FOR ONE FAMILY AND IRRIGATION OF 1.0 ACRE.

This right was perfected under Permit 30805. The date of priority is AUGUST 5, 1965. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.025 CUBIC FOOT PER SECOND (CFS), BEING 0.02 CFS FOR IRRIGATION AND 0.005 CFS FOR DOMESTIC USE, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SW 1/4 NE 1/4, SECTION 31, TOWNSHIP 39 SOUTH, RANGE 8 WEST, W.M.; 290 FEET SOUTH AND 720 FEET WEST FROM THE NE CORNER, SW 1/4 NE 1/4, SECTION 31.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-FIFTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 ½ acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

SW 1/4 NE 1/4 1.0 ACRE AND DOMESTIC USE

SECTION 31

CONSTRUCTOR OF CONTROL O

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate is issued to CONFIRM THE REMAINING RIGHT NOT CANCELED BY ORDER OF THE WATER RESOURCES DIRECTOR entered OCTOBER 27, 1987, and supersedes Certificate 38963, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
