CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

STATE OF OREGON
WATER RESOURCES DEPARTMENT

confirms the right to use the waters of BEAVER CREEK, a tributary of the APPLGATE RIVER, to maintain instream flows for FISHERIES ENHANCEMENT.

This right was confirmed by decree of the Circuit Court of the State of Oregon for JACKSON County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 4, at Page 1. The date of priority is 1876.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.40 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source, during the period FROM APRIL 1 TO BEFORE NOVEMBER 1 of each year.

The authorized point of diversion is located as follows:

NW $\frac{1}{4}$ SW $\frac{1}{4}$, SECTION 3, T 40 S, R 3 W, W.M.; 1145 FEET SOUTH AND 310 FEET EAST FROM THE W $\frac{1}{4}$ CORNER, SECTION 3.

A description of the place of use to which this right is appurtenant is as follows:

From the authorized point of diversion in the NW $\frac{1}{4}$ SW $\frac{1}{4}$, SECTION 3, T 40 S, R 3 W, W.M.; 1145 FEET SOUTH AND 310 FEET EAST FROM THE W $\frac{1}{4}$ CORNER, SECTION 3, TO THE MOUTH OF BEAVER CREEK.

This instream right shall replace a portion of the existing instream rights for BEAVER CREEK, evidenced by CERTIFICATE 72710, during the irrigation season each year, FROM APRIL 1 TO BEFORE NOVEMBER 1 OF EACH YEAR.


This certificate is issued to correct a scrivener's error in the certificate recorded at page 79087, State Record of Water Right Certificates. Certificate 79087 incorrectly listed the rate. This certificate supercedes Certificate 79087.

This certificate is issued to confirm a change in use and place of use approved by an order of the Water Resources Director approving Transfer 8569, and supersedes Certificate 16445, State Record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use in the place of use described and is subject to all other conditions and limitations contained in said decree.
