confirms the right to use the waters of EVANS CREEK, a tributary of ROGUE RIVER, for STOCK, AND IRRIGATION OF 2.5 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for JACKSON COUNTY. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 16, at Page 523. The date of priority is 1902.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.042 CUBIC FOOT PER SECOND (IF AVAILABLE AT THE ORIGINAL POINT OF DIVERSION, VROMAN DITCH - SE 1/4 NE 1/4, SECTION 11, TOWNSHIP 35 SOUTH, RANGE 4 WEST, W.M.).

The point of diversion is located as follows:

NW 1/4 NW 1/4, SECTION 25, TOWNSHIP 34 SOUTH, RANGE 3 WEST, W.M.; 150 FEET SOUTH AND 240 FEET EAST FROM NW CORNER OF SECTION 25.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

NE 1/4 SW 1/4 2.5 ACRES SECTION 24 TOWNSHIP 34 SOUTH, RANGE 3 WEST, W.M.

This certificate is issued to confirm a change in place of use and point of diversion approved by an order of the Water Resources Director entered January 6, 1983, and together with Certificate 54031, 57576, 57577 and 57578, supersedes Certificate 46876, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
