CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of WELL NO. 3 in the COLUMBIA RIVER BASIN for IRRIGATION OF 126.7 ACRES.

This right was perfected under Permit G-9400. The date of priority is APRIL 29, 1975. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1.58 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the well.

The well is located as follows:

SE 1/4 NE 1/4, SECTION 31, TOWNSHIP 2 NORTH, RANGE 24 EAST, W.M.; 10 FEET NORTH AND 10 FEET WEST FROM THE E 1/4 CORNER OF SECTION 31.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

SW 1/4 NE 1/4	22.0 ACRES
SE 1/4 NE 1/4	24.1 ACRES
NE 1/4 SE 1/4	37.4 ACRES
NW 1/4 SE 1/4	35.6 ACRES
SW 1/4 SE 1/4	3.7 ACRES
SE 1/4 SE 1/4	3.9 ACRES

SECTION 31
TOWNSHIP 2 NORTH, RANGE 24 EAST, W.M.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

This certificate is issued to confirm that a change in POINT OF APPROPRIATION WAS NOT DEVELOPED, approved by an order of the Water Resources Director entered NOVEMBER 6, 1992, and supersedes Certificate 57223, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
