CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JOHN M. LAWRENTZ CONIFER LN, CAVITT RD. GLIDE, OR 97443

confirms the right to use the waters of A SPRING AND LITTLE RIVER, tributaries of THE NORTH UMPQUA RIVER, for DOMESTIC USE FOR ONE FAMILY AND IRRIGATION OF 6.4 ACRES.

This right was perfected under Permit 37947. The date of priority is JANUARY 24, 1973. This right is limited to 0.085 CUBIC FOOT PER SECOND (CFS), BEING 0.005 CFS FOR DOMESTIC USE AND 0.02 CFS FOR IRRIGATION FROM THE SPRING AND 0.06 CFS FROM LITTLE RIVER FOR IRRIGATION, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

SPRING - NW 1/4 SW 1/4, SECTION 2, TOWNSHIP 27 SOUTH, RANGE 3 WEST, W.M.: 2550 FEET NORTH AND 2560 FEET WEST FROM THE SOUTH 1/4 CORNER OF SECTION 2; AND

RIVER - NE 1/4 SW 1/4, SECTION 2, TOWNSHIP 27 SOUTH, RANGE 3 WEST, W.M.; 2480 FEET NORTH AND 940 FEET WEST FROM THE SOUTH 1/4 CORNER OF SECTION 2.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

> RIVER SPRING

NE 1/4 SW 1/4 2.5 ACRES

1.4 ACRES AND DOMESTIC NW 1/4 SW 1/4 2.5 ACRES SECTION 2

TOWNSHIP 27 SOUTH, RANGE 3 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
