## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters from A SPRING AND AN UNNAMED STREAM, TRIBUTARIES OF SLIDE CREEK, AND SLIDE CREEK, A TRIBUTARY OF NORTH MYRTLE CREEK, AND AN UNNAMED RESERVOIR, CONSTRUCTED UNDER PERMIT R-11106, for IRRIGATION OF 15.2 ACRES AND DOMESTIC USE FOR ONE FAMILY INCLUDING IRRIGATION OF NOT TO EXCEED ONE-HALF ACRE LAWN AND NONCOMMERCIAL GARDEN.

This right was perfected under Permit 50667. The date of priority is MARCH 27, 1989 FOR 0.19 CFS FROM SLIDE CREEK AND RESERVOIR FOR IRRIGATION AND 0.005 CFS FROM STREAM AND SPRING, AND MAY 30, 1989 FOR 0.005 CFS FROM STREAM AND SPRING FOR DOMESTIC SUPPLIES. This right is limited to 0.2 CUBIC FOOT PER SECOND (CFS), BEING 0.19 CFS FROM SLIDE CREEK AND RESERVOIR FOR IRRIGATION; AND 0.01 CFS FOR DOMESTIC USE FOR ONE FAMILY INCLUDING IRRIGATION OF NOT TO EXCEED ONE-HALF ACRE LAWN AND NONCOMMERCIAL GARDEN, BEING 0.001 CFS FROM SPRING AND 0.009 CFS FROM STREAM, or its equivalent in case of rotation, measured at the point of diversion from the source.

- POD 6: SLIDE CR. SE 1/4 SE 1/4, SECTION 34, TOWNSHIP 28 SOUTH, RANGE 4 WEST, W.M.; 1600 FEET SOUTH AND 1240 FEET WEST FROM THE EAST 1/4 CORNER OF SECTION 34;
- POD 7: SLIDE CR. SW 1/4 SE 1/4, SECTION 34, TOWNSHIP 28 SOUTH, RANGE 4 WEST, W.M.; 1760 FEET SOUTH AND 1980 FEET WEST FROM THE EAST 1/4 CORNER OF SECTION 34; AND
- POD 8: RESERVOIR NE 1/4 SE 1/4, SECTION 34, TOWNSHIP 28 SOUTH, RANGE 4 WEST, W.M.; 480 FEET SOUTH AND 340 FEET WEST FROM THE EAST 1/4 CORNER OF SECTION 34.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year from direct flow and storage.

It is further provided that the right allowed herein for the use of direct flow shall be limited during the period July 15 through September 30 of each year to human consumption, livestock consumption for such animals as are essential to the proper sustenance of the family and irrigation of a noncommercial garden not to exceed one-half acre in area.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

TOWNSHIP 28 SOUTH, RANGE 4 WEST, W.M.

Failure to comply with any of the provisions of this right may result in action including, but not limited to restrictions on the use, civil penalties, or cancellation of the right.

This right is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
