CERTIFICATE OF WATER RIGHT

OTIS VALLEY IRRIGATION COMPANY, INC. P.O. BOX 234
DREWSEY, OREGON 97904

confirms the right to use the waters of COTTONWOOD CREEK AND COTTONWOOD RESERVOIR CONSTRUCTED UNDER PERMIT R-4699, a tributary of MIDDLE FORK MALHEUR RIVER, for PRIMARY IRRIGATION OF 23.1 ACRES AND SUPPLEMENTAL IRRIGATION OF 1629.4 ACRES.

This right was perfected under Permit 31115. The date of priority is JUNE 8, 1959. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 21.0 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
