CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

WADE G. GIPSON AND KIMI J. GIPSON  
C/O THE ASSOCIATES REAL ESTATE

confirms the right to use the waters of A WELL in the MCKAY CREEK  
(CROOKED RIVER) BASIN for IRRIGATION OF 4.5 ACRES.

This right was perfected under Permit G-1220. The date of priority is  
JULY 30, 1958. The amount of water to which this right is entitled is  
limited to an amount actually beneficially used and shall not exceed  
0.06 CUBIC FOOT PER SECOND, or its equivalent in case of rotation,  
measured at the well.

The well is located as follows:

SE 1/4 SW 1/4, SECTION 24, TOWNSHIP 14 SOUTH, RANGE 15 EAST, W.M.; 12  
CHAINS NORTH AND 35 CHAINS EAST FROM THE SW CORNER OF SECTION 24.

The amount of water used for irrigation, together with the amount  
secured under any other right existing for the same lands, is limited  
to ONE-EIGHTIETH of one cubic foot per second per acre, or its  
equivalent for each acre irrigated and shall be further limited to a  
diversion of not to exceed 3.0 acre-feet per acre for each acre  
irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be  
ordered by the proper state officer.

A description of the place of use to which this right is appurtenant  
is as follows:

SE 1/4 SW 1/4 4.5 ACRES  
SECTION 24  
TOWNSHIP 14 SOUTH, RANGE 15 EAST, W.M.

Land on which water is to be used is part of that described as  
follows:

Tract #16 of Brookfield Acres more particularly described as follows:  
Commencing at a point 1980 feet East; thence 664 feet North to the  
place of beginning from the Southwest corner of Section 24, Township  
14 South, Range 15 East, W.M. thence North 332 feet; thence East 660  
feet; thence South 332 feet; thence West 660 feet to the place of  
beginning.
