CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of WELLS NO. 1 AND 2 in the WILLAMETTE RIVER BASIN for DOMESTIC USE FOR 68 FAMILIES INCLUDING THE IRRIGATION OF NOT TO EXCEED ONE-HALF ACRE LAWN AND NON-COMMERCIAL GARDEN FOR EACH FAMILY AND USE AT TWO COMMUNITY SERVICE USES INCLUDING SWIMMING POOL AND SANITARY FACILITIES AT TWO BUILDINGS.

This right was perfected under Permit G-10678. The date of priority is OCTOBER 7, 1986. This right is limited to 105.0 GALLONS PER MINUTE (GPM); BEING 100.0 GPM FOR DOMESTIC USE AND 5.0 GPM FOR COMMUNITY SERVICE USE or its equivalent in case of rotation, measured at the well.

The well is located as follows:

WELL NO. 1 - NW 1/4 NW 1/4, AS PROJECTED WITHIN DLC 46, SECTION 22, T 3 S, R 1 E, W.M.; 660 FEET SOUTH AND 600 FEET EAST FROM THE NORTHWEST CORNER OF SECTION 22; AND

WELL NO. 2 - NW 1/4 NW 1/4, AS PROJECTED WITHIN DLC 46, SECTION 22, T 3 S, R 1 E, W.M.; 590 FEET SOUTH AND 575 FEET EAST FROM THE NORTHWEST CORNER OF SECTION 22.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

This certificate is issued to confirm a change in POINT OF APPROPRIATION approved by an order of the Water Resources Director entered JANUARY 21, 1999.

The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

The water user shall install and maintain a weir, meter, or other suitable measuring device, and keep a complete record of the amount of ground water withdrawn.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.
