CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

DEE R. PEREIRA 1488 NW GROVE LN ROSEBURG, OREGON 97470

confirms the right to use the waters of TWO SUMP WELLS in the NORTH UMPOUA RIVER BASIN for IRRIGATING 3.9 ACRES.

This right was perfected under Permit G-10823. The date of priority is OCTOBER 7, 1987. This right is limited to 0.05 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the well.

The sump wells are located as follows:

SUMP WELL NO. 1 - SE 1/4 SW 1/4, AS PROJECTED WITHIN E. BUNTON DLC 45, SECTION 6, TOWNSHIP 26 SOUTH, RANGE 5 WEST, W.M.; 780 FEET NORTH AND 2100 FEET EAST FROM THE SW CORNER OF SECTION 6; AND

SUMP WELL NO. 2 - SE 1/4 SW 1/4, AS PROJECTED WITHIN E. BUNTON DLC 45, SECTION 6, TOWNSHIP 26 SOUTH, RANGE 5 WEST, W.M.; 1050 FEET NORTH AND 1870 FEET EAST FROM THE SW CORNER OF SECTION 6.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

SE 1/4 SW 1/4 3.9 ACRES
AS PROJECTED WITHIN E. BUNTON DLC 45
SECTION 6
TOWNSHIP 26 SOUTH, RANGE 5 WEST, W.M.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

The water user shall install and maintain a weir, meter, or other suitable measuring device, and keep a complete record of the amount of ground water withdrawn.

This right is for the beneficial use of water without waste.

By law, the land use associated with this water user must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

This right shall be limited to appropriation of water only to the extent that it does not impair or substantially interfere with prior surface water rights as well as prior ground water rights of others.
