CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

WALTER N. AND MARGERY K. RITTER ROUTE 1, BOX 740 BONANZA, OREGON 97623

confirms the right to use the waters of WELL 2 in the WILD HORSE CREEK BASIN for IRRIGATION OF 154.9 ACRES AND SUPPLEMENTAL IRRIGATION OF 41.3 ACRES.

This right was perfected under Permit G-3653. The date of priority is JULY 26, 1967. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 2.21 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

SW¼ NE¼, SECTION 8, T 38 S, R 11 E, W.M.; 2610 FEET SOUTH AND 3000 FEET EAST FROM THE NW CORNER, SECTION 8.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet for each acre irrigated during the irrigation season of each year; provided further that the right allowed herein shall be limited to any deficiency in available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
