CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

RITTER RANCH INC.
28100 RITTER ROAD
BONANZA, OREGON 97623

confirms the right to use the waters of TWO WELLS in the WILD HORSE CREEK BASIN for IRRIGATION OF 11.4 ACRES.

This right was perfected under Permit G-6679. The date of priority is OCTOBER 29, 1975. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.15 CUBIC FOOT PER SECOND (CFS), BEING 0.08 CFS FROM WELL 1 AND 0.07 CFS FROM WELL 2, or its equivalent in case of rotation, measured at the well.

The wells are located as follows:

SE $\frac{1}{4}$ SW $\frac{1}{4}$, SECTION 5, AND SW $\frac{1}{4}$ SE $\frac{1}{4}$, SECTION 8, T 38 S, R 11 E, W.M.; WELL 1 - 270 FEET NORTH AND 2580 FEET EAST; WELL 2 - 2610 FEET SOUTH AND 3000 FEET EAST; BOTH FROM THE NW CORNER OF SECTION 8.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:


TOWNSHIP 38 SOUTH, RANGE 11 EAST, W.M.
