### CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ROSCOE HOWARD GRANTS PASS, OREGON 97526

confirms the right to use the waters of the ROGUE RIVER, a tributary of the PACIFIC OCEAN, for IRRIGATION AND SUPPLEMENTAL IRRIGATION.

This right was perfected under Permit 4680. The date of priority is JULY 31, 1919. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1.05 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SW1/4 SW1/4, SECTION 18, T 36 S, R 6 W, W.M..

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
