CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

STEVEN LYNN STONEBREAKER

confirms the right to use the waters of the GRANDE RONDE RIVER, a tributary of the SNAKE RIVER, for IRRIGATION OF 86.0 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for UNION County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 8, at Page 1. The date of priority is 1872.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed THREE ACRE FEET PER ACRE IN ANY IRRIGATION SEASON DIVERTED AT A RATE OF NOT TO EXCEED ONE-FORTIETH OF A CUBIC FOOT PER SECOND PER ACRE, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SW $\frac{1}{4}$  SW $\frac{1}{4}$ , SECTION 31, T 2 S, R 38 E, W.M.; ORDELL DITCH - 1858.33 FEET SOUTH AND 80.84 FEET EAST FROM THE W $\frac{1}{4}$  CORNER, SECTION 31.

A description of the place of use to which this right is appurtenant is as follows:

- SE $\frac{1}{4}$  SW $\frac{1}{4}$  9.0 ACRES
- NE $\frac{1}{4}$  SE $\frac{1}{4}$  16.8 ACRES
- NW $\frac{1}{4}$  SE $\frac{1}{4}$  20.2 ACRES
- SW $\frac{1}{4}$  SE $\frac{1}{4}$  20.0 ACRES
- SE $\frac{1}{4}$  SE $\frac{1}{4}$  20.0 ACRES



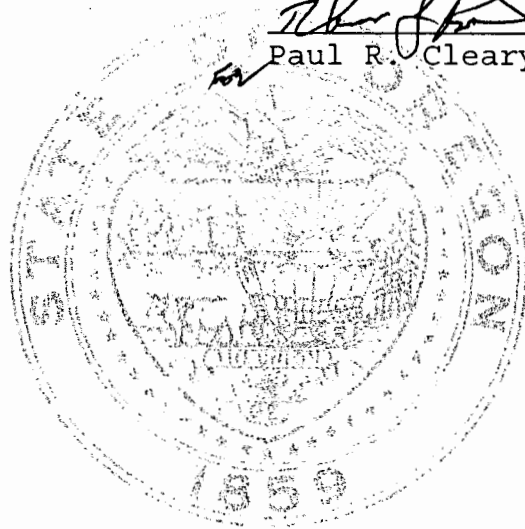
