CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ANDREW O. LUN NORTH POWDER, OREGON 97867

confirms the right to use the waters of the NORTH POWDER RIVER, a tributary of the POWDER RIVER, for IRRIGATION OF 82.0 ACRES, DOMESTIC AND STOCK USE.

This right was confirmed by decree of the Circuit Court of the State of Oregon for UNION County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 3, at Page 252. The date of priority is 1870.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 2.05 CUBIC FOOT PER SECOND (CFS) FROM MARCH 1 TO JUNE 30 AND 1.03 CFS FROM JULY 1 TO OCTOBER 1 of each year or its equivalent in case of rotation, measured at the point of diversion from the source. The total quantity diverted during each irrigation season shall not exceed 205.0 ACREFEET.

The point of diversion is located as follows:

NE% SE%, SECTION 28, T 6 S, R 39 E, W.M.; LUN DITCH - 2600 FEET NORTH AND 440 FEET WEST FROM SE CORNER, SECTION 28.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
