CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

VIRGINIA A. DAVIS
23232 SOUTHWEST STAFFORD ROAD
TUALATIN, OREGON 97062

confirms the right to use the waters of ONE WELL in the TUALATIN RIVER BASIN for IRRIGATION OF 27.6 ACRES.

This right was perfected under Permit G-10024. The date of priority is JULY 19, 1982. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.07 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the well.

The well is located as follows:

NW 1/4 SE 1/4, SECTION 31, TOWNSHIP 2 SOUTH, RANGE 1 EAST, W.M.; 1170 FEET SOUTH AND 450 FEET EAST FROM THE CENTER 1/4 CORNER OF SECTION 31.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/4 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

SE 1/4 NE 1/4 0.2 ACRE
NE 1/4 SE 1/4 4.2 ACRES
NW 1/4 SE 1/4 23.0 ACRES
NE 1/4 SW 1/4 0.2 ACRE

SECTION 31
TOWNSHIP 2 SOUTH, RANGE 1 EAST, W.M.

The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.


