CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

VERLE EMERY

confirms the right to use the waters of WELL 2 in the SUMMER LAKE BASIN for IRRIGATION OF 67.1 ACRES.

This right was perfected under Permit G-10388. The date of priority is MARCH 27, 1984. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.84 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

SE $\frac{1}{4}$ SW $\frac{1}{4}$, SECTION 10, T 31 S, R 16 E, W.M.; 1439 FEET SOUTH AND 484 FEET WEST FROM THE C $\frac{1}{4}$ CORNER, SECTION 10.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

SW¼ SW¼ 4.3 ACRES
SE¼ SW¼ 30.4 ACRES
SW¼ SE¼ 4.1 ACRES

SECTION 10

NW¼ NE¼ 2.3 ACRES
NE¼ NW¼ 23.2 ACRES
NW¼ NW¼ 2.8 ACRES

SECTION 15

TOWNSHIP 31 SOUTH, RANGE 16 EAST, W.M.

The well shall be maintained in accordance with the Genral Standards for the Construction and Maintenance of Water Wells in Oregon.



The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
