## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ARDELL LOERTS 5651 LOOKINGGLASS RD ROSEBURG, OR 97470

confirms the right to use the waters of COW HOLLOW, a tributary of LOOKINGGLASS CREEK, for IRRIGATION of 13.8 ACRES.

This right was perfected under Permit 24468. The date of priority is SEPTEMBER 4, 1956. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.17 CUBIC FOOT PER SECOND or the equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NW% SW%, AS PROJECTED WITHIN WILLIAMS DLC 46, SECTION 30, TOWNSHIP 27 SOUTH, RANGE 6 WEST, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or the equivalent for each acre irrigated, and is further limited to a diversion of not to exceed 2.5 acre-feet for each acre irrigated during the irrigation season of each year.

A description of the place of use to which this right is appurtenant is as follows:

This certificate is issued to correct a scrivener's error contained in the certificate recorded at page 78831, State Record of Water Right Certificates. Certificate 78331 incorrectly described the lands to which the water right is appurtenant.

This certificate describes that portion of the water right confirmed by Certificate 32426, State Record of Water Right Certificates, NOT canceled by the provisions of an order of the Water Resources Director entered December 6, 2001, and recorded at Special Order Volume 55, Page 323, canceling a portion of said water right. This Certificate supersedes Certificate 78831.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
