## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

CORA B. CRUMP, ADMINISTRATRIX OF THE ESTATE OF J.F. CRUMP, DECEASED BUNCOM, OREGON 97530

confirms the right to use the waters of YALE CREEK, OR RIGHT FORK OF LITTLE APPLEGATE RIVER, a tributary of the APPLEGATE RIVER, for IRRIGATION OF 59.1 ACRES AND THE DEVELOPMENT OF 4 HORSEPOWER.

This right was confirmed by decree of the Circuit Court of the State of Oregon for JACKSON County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 4, at Page 1. The date of priority is 1865 FOR 0.69 CUBIC FOOT PER SECOND (CFS) FOR IRRIGATION OF 27.6 ACRES; 1880 FOR 0.63 CFS FOR IRRIGATION OF 25.0 ACRES; 1907 FOR 0.16 CFS FOR IRRIGATION OF 6.5 ACRES, DOMESTIC AND STOCK USE; AND 1907 FOR 0.15 CFS FOR FARM POWER WHEEL.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1.63 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

A description of the place of use to which this right is appurtenant is as follows:

This certificate describes that portion of the water right confirmed by Certificate 43583, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director SEP 1 8 2002 \_\_\_\_\_, approving Transfer Application 8892.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.

The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
