CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

CHARLES TULLIS, JR.
PENDLETON, OREGON 97801

confirms the right to use the waters of MCKAY CREEK, a tributary of the UMATILLA RIVER, for IRRIGATION OF 19.0 ACRES.

This right was perfected under Permit 5996. The date of priority is AUGUST 16, 1923. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.24 CUBIC FOOT PER SECOND, if available at the original point of diversion, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as described below.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.


This certificate describes that portion of the water right confirmed by Certificate 75447, State Record of Water Right Certificates, NOT modified by a partial cancellation and the provisions of an order of the Water Resources Director entered SEP 30 2002, approving Transfer Application 7837.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
