CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

CHESTER PRIOR
32327 OREGON TRAIL ROAD
ECHO, OREGON 97826

confirms the right to use the waters of THREE WELLS in the UMATILLA RIVER BASIN for IRRIGATION OF 267.2 ACRES.

This right was perfected under Permit G-6588. The date of priority is OCTOBER 15, 1975. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 3.34 CUBIC FEET PER SECOND (IF AVAILABLE AT THE ORIGINAL POINT OF APPROPRIATION DESCRIBED BELOW), or its equivalent in case of rotation, measured at the well.

The wells are located as follows:

WELL (ORIGINAL WELL) - NW 11/4 NE 1/4, SECTION 10, TOWNSHIP 2 NORTH, RANGE 28 EAST, W.M.; 1020 FEET SOUTH AND 1670 FEET WEST FROM THE NE CORNER, SECTION 10; AND

WELL NO. 4 - SE 1/4 NW 1/4, SECTION 1, TOWNSHIP 2 NORTH, RANGE 28 EAST, W.M.; 2640 FEET SOUTH AND 630 FEET WEST FROM THE N 1/4 CORNER OF SECTION 1; AND

WELL NO. 8 - NE 1/4 SE 1/4, SECTION 2, TOWNSHIP 2 NORTH, RANGE 28 EAST, W.M.; 2800 FEET SOUTH AND 500 FEET WEST FROM THE NE CORNER OF SECTION 2.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review of the order must be filed within the 60 days of the date of service.

A description of the place of use to which this right is appurtenant is as follows:

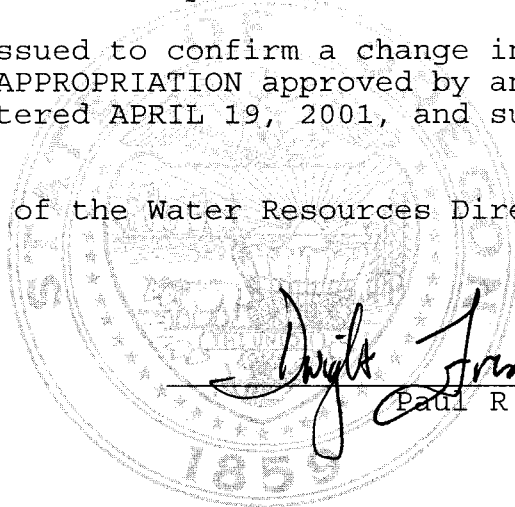
The water user shall maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted.

The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate is issued to confirm a change in PLACE OF USE AND ADDITIONAL POINTS OF APPROPRIATION approved by an order of the Water Resources Director entered APRIL 19, 2001, and supersedes Certificate 54564.
